Consent for hyaluronic acid fillers (Restylane, Perlane, Juvederm)

I understand that the above fillers are composed of stabilized hyaluronic acid, a substance occurring naturally in the human body, and produced from non-animal sources. The substance is injected under the skin with a small needle to produce filling and softening of wrinkles and folds associated with aging changes, scarring and other conditions I desire to improve or correct.

A topical anesthetic such as lidocaine ointment will be placed on the skin to be injected to numb it and ice packs may be used in addition. For filling of lips Dr. Owings recommends a nerve block of the lips which is painless to administer and produces numbing similar to that occurring during dental procedures.

The duration of effect of these substances is variable and usually lasts from 4 months to as long as a year. When BOTOX is given in the same areas, the effect is prolonged, though in most cases BOTOX can not be used in the lower face or lips.

Initially swelling (especially in the lips), bruising and mild pain or discomfort may occur; this usually resolves in a few days though swelling of the lips can last up to one week or longer. It takes about two weeks to see the final result, and at that time a “tune-up” can be done if any asymmetry or unevenness occurs. Some lumpiness may also occur but will resolve over time.

After treatment avoid excessive heat, sun exposure or cold and don't rub the treated areas for at least 24 hours. Ice applied to the treated areas for the first 24 hours will lessen swelling and the tendency to bruise.

I understand this is an elective and voluntary cosmetic procedure and that payment is my responsibility at the time of service.

CONSENT FOR BOTOX COSMETIC

I am aware that when a small amount of purified botulinum toxin (BOTOX) is injected into a muscle it causes weakness or paralysis. This appears in 3-4 days and usually last about 4 months but can last longer or shorter. For example, injecting BOTOX into the muscles between the eyebrows can result in improvement or disappearance of frown lines.

RESULTS AND POSTOPERATIVE CARE

I understand I will not be able to move the treated muscle(s) while the injection is effective but that this will reverse itself after a period of months, at which time retreatment may be done. I understand I should remain in an upright position and not manipulate, rub or press on the injection sites for four hours after the injections take place.

RISKS AND COMPLICATIONS

BOTOX treatment can cause temporary drop of one or both eyelids which can last 2-3 weeks; this occurrence is uncommon, occurring in about 1-2% of patients, and can be corrected if desired, until it resolves naturally, with prescription eye drops. Rarely numbness of the forehead can occur, also lasting 2-3 weeks, as well as bruising, swelling, facial pain and headache. In a very small number of individuals BOTOX either does not work or doesn't last as long as expected.
